## ICFAI Law School, IFHE, Hyderabad

The Legal Aid Society of ICFAI Law School at IFHE, Hyderabad, organized a legal awareness program focused on the Protection of Children from Sexual Offenses (POCSO) Act, 2012, at Sujatha School in Moinabad mandal, Rangareddy district, on October 15, 2025. Students from the 9th to 12th grades, around 350 students, participated in the program. Faculty members discussed various provisions of the Act related to child sexual abuse, including safe and unsafe touch, as well as the penalties for offenders.

During the program, faculty members overviewed the importance of POCSO Act and emphasized the importance of consent and respecting personal boundaries among children and teens. It explained grooming and manipulation, helping students recognize warning signs of child sexual abuse. The talk guided them on how to respond and report unsafe situations confidently. Finally, it highlighted the role of teachers and adults in creating a culture of safety, trust, and respect for every child.

Legal aid members presented a poster outlining the process for reporting sexual abuse to parents, the police, and the school disciplinary committee. Additionally, students performed a mime act to raise awareness about child abuse, demonstrating how children can protect themselves and inform through the child helpline number (1098), the police helpline number (100), and the POCSO eBox facility under the National Commission for Protection of Child Rights. A game activity centered on being aware and alert made the session more interactive for the students.

Feedback from attendees indicated that they gained a clear understanding of the POCSO Act and its various provisions. The Act emphasizes that students should not remain silent if they experience sexual abuse; they should report such incidents immediately to their parents, the police, or school authorities.



## Legal Awareness Program on POCSO Act Held at Sujatha School

The Legal Aid Society of ICFAI Law School at IFHE, Hyderabad, organized a legal awareness program on the Protection of Children from Sexual Offenses (POCSO) Act, 2012, at Sujatha School in Moinabad mandal, Rangareddy district, on October 15, 2025. The initiative aimed to educate students about their rights and the legal framework designed to protect them from sexual abuse.

Around 350 students from classes 9 to 12 took part in the program. Faculty members of ICFAI Law School explained key provisions of the POCSO Act, focusing on identifying safe and unsafe touch and un-



derstanding the legal consequences for offenders.

Representatives from the Legal Aid Society also presented a poster detailing the procedure for reporting incidents of sexual abuse to parents, the police, or the school disciplinary committee. As part of the event, students performed a mime act depicting scenarios of child abuse, emphasizing self-protection of measures and encouraging the truse of the child helpline number (1098), police helpline (100), and the POCSO eBox platform under the National Commission for Protection of Child Rights.

Students shared positive feedback, stating that the session enhanced their awareness of the Act and the importance of speaking up against abuse. They learned that remaining silent about such incidents can perpetuate harm, while timely reporting ensures protection and justice. The event was funded by the IFHE Management as part of its ongoing efforts to promote legal literacy and awareness among school students across Telangana.
