This initiative enhances students' understanding of international law, environmental policies, and multilateral negotiations while cultivating leadership, teamwork, and advocacy. It highlights ICFAI's vision of producing market-ready legal professionals capable of addressing complex socio-economic and political issues.



The Model COP reflects the school's mission to blend theory with practice, enrich intellectual and professional growth, and reinforce its standing as a Centre for Excellence in Legal Education. By prioritizing community involvement and climate action, this event instills environmental consciousness and responsibility in students, preparing them as future leaders and advocates for sustainable development.

CONFERENCE OF PARTIES (COP)

The Conference of the Parties (COP) is the supreme decision-making body of the UNFCCC, comprising 198 nations including the European Union. Held annually by the UNFCCC Secretariat, it brings together world leaders, negotiators, scientists, businesses, and civil society to review climate progress, strengthen commitments, negotiate agreements, and coordinate actions against global warming. At each summit, countries submit emission data, form negotiating blocs, and debate key issues such as climate finance, adaptation, mitigation, technology transfer, and biodiversity protection. COP has produced landmark agreements like the Kyoto Protocol and the Paris Agreement, shaping the global climate agenda. The upcoming COP30 will be hosted in Belém, Brazil, from November 10–21, 2025, marking the first time it will be held in the Amazon rainforest region and emphasizing Brazil's vital role in global climate action.



ABOUT MODEL COP

COP The Model COP (Model Conference of the Parties) is an inspiring, multi-day simulation modeled after United Nations COP summits, designed to empower young people to step into the shoes of international climate negotiators and leaders. Participants serve as delegates for nations, blocs, or organizations, engaging dynamically in real-world negotiation roles that address urgent topics such as climate adaptation, sustainable development, climate finance, and biodiversity protection.

REGISTRATIONS

Eligibility - School students from class 9 to 12, undergraduate students, and post-graduation students are eligible to enroll for the event. The age from 15 years to 30 years age students are eligible to enroll. (STUDENS FROM ANY STREAM OF STUDY CAN PARTICIPATE)

Mode of Registration: Registration will be done through a Form, which will be circulated by the Organizing Committee.

Confirmation: After successful registration, a confirmation mail will be sent to the participants along with details of country allotment, information about the accommodation and waiver form.
