**Eligibility:** Pass in Class XII in any discipline or equivalent recognized by the respective boards.

**Fee:** ₹12,000 per each Certificate Course.

**Medium of Instruction:** The medium of instruction for all Certificate Courses is English only.

**Library:** ICAI Law School (ILS) has a separate law library in addition to the IFHE general library. It has the print collection, online resources, physical and electronic journals and books. It contains reference books, text books and general books, the central manuals, Law Commission Reports, draft bills, case digests, All India Reports etc. The library has a good collection of law journals such as Arbitration Law Report, Company Law Journal, Tax Law Journal, Journal of Indian Law Institute, Supreme Court Cases, All India Reporter (AIR), Journal of Bar Council of India (Indian Bar Review) and access to the various national and international journals through net resources.

**Online Database:** ILS is subscribing for two online databases, namely: Manupatra and West Law, which provides access to Judgements of Supreme Court, High Court and Other Courts, International Database, Bare Acts, Text Books, Articles in Journals, reports of various committees and other information relating to legal education.

## Research Centers

**Center for Cyber Law:** ILS has established Centre for Cyber Law with an objective to encourage the student and researcher to find solutions for various legal issues associated with information technology. It also imparts a certificate course on Cyber Laws.

**Center for Environmental Studies:** ILS has initiated and established the Centre for Environmental Studies (CES) with an objective of bringing awareness on environment related issues and sensitization programs. It offers a certificate program in Solid Waste Management.

**Center of Postgraduate Legal Studies:** ILS has launched the 'Centre of Post-graduate Legal Studies' with an objective of imparting the post-graduate level, one year full time LLM program in Corporate and Commercial Laws now, and later, Ph.D program in Law.

**Case Research Center:** ILS is establishing a Case Research Center to enable its faculty and students to undertake research activities in the analysis of cases pronounced by various national and international courts on the topics of importance.

## Admission Process:

## Fee Schedule

**Payment Schedule:** Applicants selected for the Certificate Courses of IFHE, Hyderabad are required to pay the Fee as follows.

**Program Fee:** The Fee is ₹12,000 per each Certificate Course. Students are required to pay the Fee before the commencement of classes on or before **September 13, 2017**.
