CALL FOR PAPERS

The conference invites original research articles on the aforementioned themes and subthemes from academicians, researchers, students, and professionals. This includes individuals interested in mental health and criminal behavior or related subjects, such as those working within the Criminal Justice System, mental healthcare professionals, and NGO practitioners. An abstract of 300 words should be submitted on or before February 25, 2025. The abstract should be submitted through the link: <u>Click Here</u>

Notification of abstract acceptance will be communicated within 15 days of submission. Following the acceptance of the abstract, the full paper should be submitted on or before March 10, 2025. The link for the submission of the full paper will be sent along with the acceptance of the abstract.

SUBMISSION GUIDELINES

- The abstract should be 300 words with a minimum of five (5) keywords and must be accompanied by a cover page with the author's/co-author's details.
- The abstract must be submitted via Google Forms. The link to the same is here: <u>Click</u> <u>Here</u> .
- Word Limit: Full papers should be between 4000 6000 words, including footnotes.
- Formatting: Times New Roman, 12 pt font for the main text and 10 pt for footnotes.
- Margins: 2.54 cm on all sides (normal).
- Citation Style: Bluebook 21st Edition.
- File Format: Microsoft Word (.doc/.docx).
- Embed all figures, tables, and images within the document and cite them consecutively in the text.
- Ensure each table has a descriptive title and that units are specified in column headings where applicable.
- The submission should be in English.
- A maximum of two co-authors are permitted.
- Selected papers may be facilitated for publication with a reputed publisher. A few selected papers will be published in the form of an edited book with ISBN number, subject to the decision of the review committee.
- The full Paper should be submitted with a plagiarism report.
- After acceptance of the abstract, the full paper must be submitted via the Google form link, which will be provided after acceptance.

Plagiarism Policy:

The conference has a strict anti-plagiarism policy, permitting up to 10% similarity, with a maximum of 5% AI-generated content. Papers that exceed this limit will be disqualified.
