- Should be qualified in the ICFAI Law School Admission Test for PG Programs 2025 conducted by ICFAI Law School, IFHE, Hyderabad.
- The applicants appearing for final year examination and awaiting results may also apply for the Admission Test.
- The admission however, remain provisional until they produce mark sheets establishing their eligibility.
- The last date for submitting the proof of eligibility is September 18, 2025, failing which the provisional admission will automatically stand cancelled.
