- Should have qualified in the ILSAT (PG) 2025 conducted by ICFAI Law School, IFHE, Hyderabad.
- The candidate should have enrolled himself/ herself as an advocate for a period of at least one year and should have working experience minimum of 2 years in any law firm or corporate legal department.
- The admission however, remain provisional until they produce mark sheets establishing their eligibility.
- The last date for submitting the proof of eligibility is September 18, 2025, failing which the provisional admission will automatically stand cancelled.
