Inaugural Ceremony


Distinguished Lecture Series on Sustainable Development Goals

Restructuring and Remandating Agriculture for Jobs and Income


ICFAI Law School, IFHE, Hyderabad, organized the second lecture of its SDGs Lecture Series on March 14, 2025, titled "Restructuring and Remandating Agriculture for Jobs and Income." Hosted by the Centre for Excellence in Environment and Forest Laws, the session featured Dr. Ashok Dalwai, Chairman of the Karnataka Agriculture Price Commission and ISEC, Bengaluru, as the keynote speaker.

Dr. Dalwai emphasized the need for structural reforms in agriculture to enhance productivity, income generation, and rural employment. He advocated for diversification into agro-processing, dairy farming, and horticulture, alongside market and technological reforms. He linked these strategies to SDG 2 (Zero Hunger), SDG 8 (Decent Work and Economic Growth), and SDG 13 (Climate Action), underscoring the importance of sustainable and inclusive agricultural growth.
