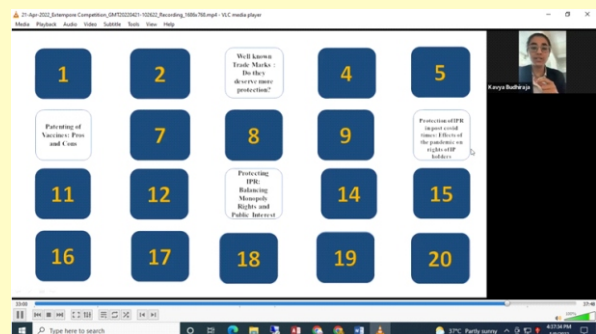
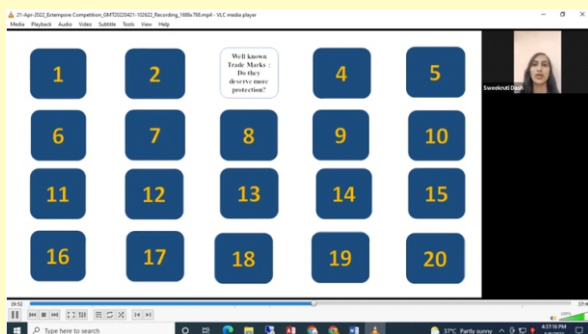


# Extempore Competition

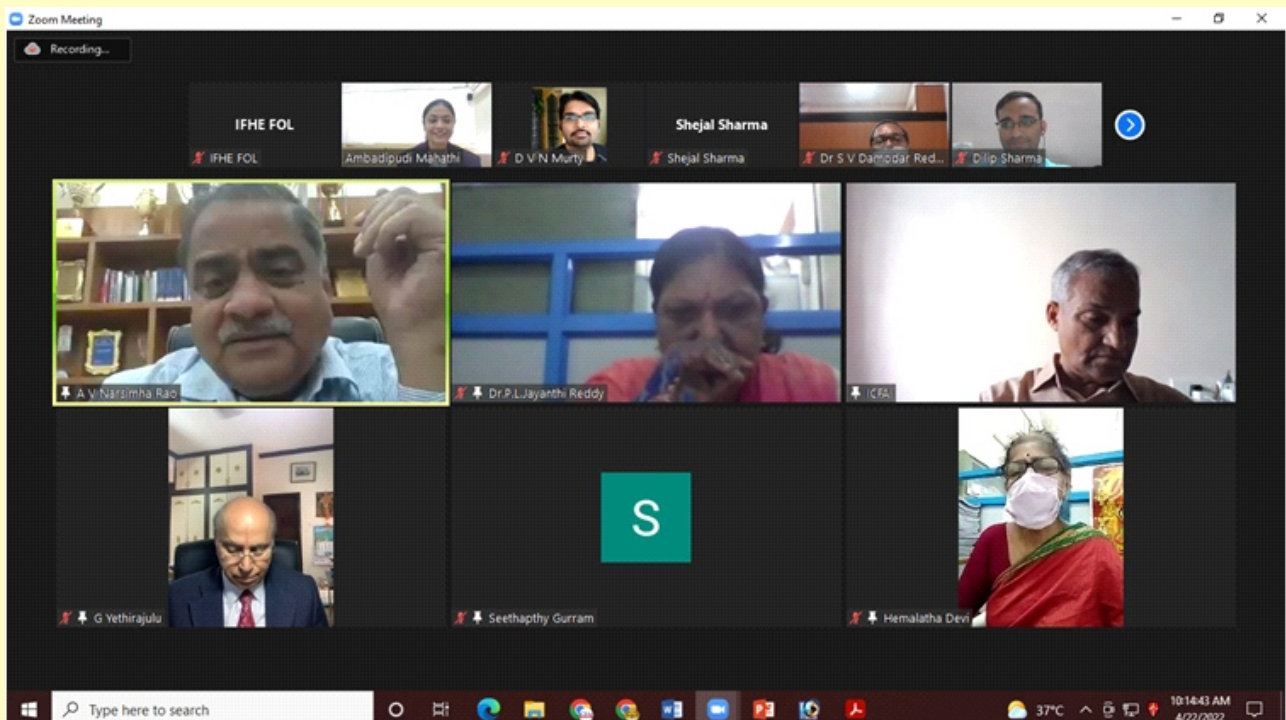
# Asian Parliamentary Debate
