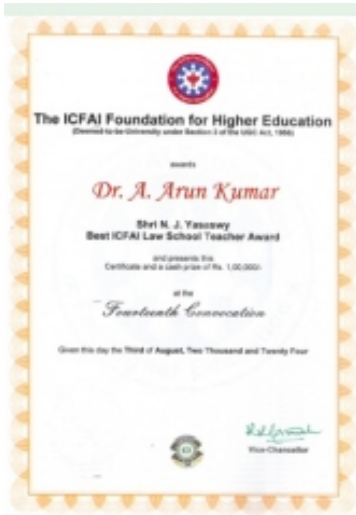

‘Juvenile Justice System: Interventions and Legal Protections for Children in Need of Care and Protection’ (Online)

The Legal Aid Society of ICFAI Law School hosted an online Legal Aid Conclave on "Juvenile Justice System: Interventions and Legal Protections for Children in Need of Care and Protection" on 28 August 2024. The conclave aimed to provide an in-depth analysis of the legal frameworks and protections for vulnerable children within the juvenile justice system.

The event commenced with an inaugural address by Prof. Pratap Reddy, Dean of ICFAI Law School, Hyderabad. In his remarks, Prof. Reddy underscored the necessity of continued advocacy, legal reforms, and policy improvements to protect children at risk and urged students to actively participate in the discussions.

The session was led by Dr. Rama Devi Gudemela, an esteemed authority in international law, human rights, and child welfare. Currently, serving as a Member of the Child Welfare Committee in Ranga Reddy District, Dr. Gudimel is highly regarded for her scholarly work on inter-country adoption, including her seminal book on adoption laws in India. In addition to her expertise in child welfare, Dr. Gudemela is a certified POSH trainer and mediator.

In her presentation, Dr. Gudemela highlighted the critical legislative frameworks that govern juvenile justice in India, focusing on key laws and their prohibitions aimed at safeguarding children's rights and well-being. She provided insights into the practical implementation of these laws, underscoring the importance of robust legal protections for children in need of care and protection.

The conclave concluded with an engaging Q&A session, where participants could interact with Dr. Gudemela and seek clarity on pressing issues. The lively exchange reflected a deep commitment to improving the juvenile justice system, and the discussions reinforced the need for ongoing advocacy and reform to support the well-being of children at risk.

'Protection of Children from Sexual Offences Act, 2012 (POCSO)'

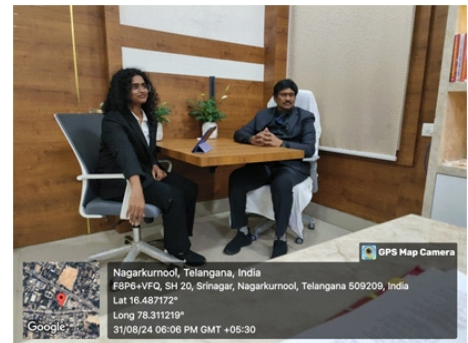
