Ms. Ghosh emphasized the role of Al-driven solutions in tackling specific health issues, such as musculoskeletal conditions, and the importance of accessible and affordable care to bridge systemic gaps in healthcare. Mr. Mehra elaborated on leveraging Al and DPI to enhance early diagnosis, personalized treatments, and resource allocation. His insights underscored how scalable solutions could create a more inclusive healthcare ecosystem, ensuring essential care reaches marginalized communities. Ms. Aysola shared how AccessHealth International integrates Al and DPI to optimize real-time data analysis and equitable resource distribution, prioritizing affordability and inclusivity in health systems worldwide. Mr. Gupta emphasized predictive analytics, real-time diagnostics, and personalized care delivery enabled by Al and DPI. He highlighted the importance of interoperability across public health systems to ensure equitable access to essential services. The panel discussion concluded with a shared vision of creating resilient, patient-centric healthcare systems. The event served as an enriching platform for understanding how technology and inclusivity can address healthcare disparities and empower communities globally.

Visit to AkshayaKalpa Organic Farm Visit: Exploring Sustainable Innovation

The visit to AkshayaKalpa Organic Farm on December 22, 2024, was an enlightening experience for 58 participants, including students, faculty, and professionals from the Center of Excellence for Digital Transformation. The visit aimed to explore sustainable farming practices and understand the role of digital transformation in agriculture. AkshayaKalpa, a pioneer in the organic food and dairy sector, integrates technology and eco-friendly methods on its 60-acre farm, with a 30-acre research facility focused on advancing organic farming. Participants observed innovative



practices like precision farming, automated irrigation, and biogas production, which highlighted how technology enhances productivity and sustainability. The farm prioritizes chemical-free food production, catering to the rising consumer demand for organic products, and implements sustainable practices such as water conservation, renewable energy, and closed-loop waste recycling systems to enrich soil fertility. The farm offers diverse products, including A2 milk, flavored yogurt, paneer, unprocessed honey, and virgin coconut oil, as well as unique plant varieties like diabetes-friendly Sitaphal and Sky fruit. A network of 1,200 farmers collaborates with AkshayaKalpa, earning an average annual income of INR 14 lakh. Participants enjoyed a farm tour, where they witnessed efficient milking processes and energy-saving innovations such as motion-sensor streetlights. A key highlight was the organic lunch, complemented by a tasting session of the farm's freshly produced cheese and flavored yogurt. An interactive session by co-founder Shashi Kumar emphasized the importance of branding, consumer influence, and building trust in business strategies. The visit underscored the role of sustainable agriculture and technology in transforming farming practices. Participants gained valuable insights into promoting similar models, fostering partnerships between farms and technology providers, and raising awareness of organic products to drive market growth. The experience inspired advocacy for innovative, eco-friendly solutions that integrate sustainability and technology.

The panel discussion on the Digital Transformation of Indian Agriculture brought together Mr. Shashi Kumar, Founder and CEO of Akshayakalpa Organic, and Mr. Anantha Krishnan R.K., Principal Consultant, Emerging Technologies, ITEC Department, Government of Telangana, moderated by Prof. Shailendra Singh Bisht. The session began with a tribute to Dr. Manmohan Singh, honoring his contributions to India's economy and agriculture. Mr. Kumar shed light on the systemic challenges smallholder farmers face, including aging farmer demographics, unsustainable input-driven farming, and limited control over key factors such as market prices, soil health, and water management. He advocated for a return to ecological farming practices, emphasizing crop diversification, soil conservation, and self-reliant inputs such as seed-saving and organic manure. His vision underlined the importance of aligning scientific advancements with traditional wisdom to create sustainable farming

systems. Mr. Krishnan presented Telangana's Agriculture Data Exchange (ADEX), a pioneering Digital Public Infrastructure (DPI) designed to integrate data from multiple government departments into a unified platform. This initiative facilitates access to crucial information for startups, researchers, and financial institutions, enabling solutions tailored to farmers' needs. A notable example is ADEX's collaboration with HDFC Bank, allowing crop loans to be processed within two days, addressing delays that often forced farmers to rely on exploitative moneylenders. The discussion concluded with a call for collective action, urging students and professionals to leverage digital technologies and contribute to making agriculture sustainable, inclusive, and resilient. Both speakers emphasized the critical role of innovation, policy, and community involvement in transforming Indian agriculture and securing its future.

Editorial

India's SDG focus and its human development issues

n September 9-10, 2023, New Delhi hosted the G-20 Summit, which resolved to accelerate the full and effective implementation of the UN Agenda 2030 for Sustainable Development. On September 18-19, 2023, an "SDG Summit" was convened at the United Nations headquarters to follow up and review the implementation of the Agenda and the review the implementation of the Agenda and the review the implementation of the Agenda and the progress of the 17 Sustainable Development Goals (SDGs). A "Summit of the Future" took place on September 22-23, 2024, at the UN headquarters to build upon the SDG Summit 2023 and its commitments by member nations.

In this context, examining India's progress in human development since 1990, based on the UNDP's latest Human Development Report (HDR), is valid. As said by Nobel laureate Amartya Sen in his book, *Development as Freedom*, 'development is a process of expanding the real freedoms that people enjoy'. In his 'capability approach', the basic concern of human development is 'our capability to lead the kind of lives we have reason to value'. Freedom from hunger and ill-health on the one hand and gender and income equality, and access to quality education on the other hand lead to the achievement of human development, and, consequently, to sustainable development.

Development and the SDGs The Human Development Index (HDI) developed by the UNDP has three dimensions: long and healthy life (measured by life expectancy at birth); knowledge (expected years of schooling and mean years of schooling), and a decent standard of living (income per capita). All the three dimensions are much related to some of the key SDG: SDG-3 (good health); SDG-4 (quality education); SDG-5 (gender equality); SDG-8 (decent work) and SDG-10 (reduced inequality). Clearly, countries aspiring to achieve sustainable

The HDR 2023-24 places India in the 'medium human development category' with a human development index (HDI) value of 0.644. India ranks 134 out of 193 countries. The HDI value was stagnant in 2019-20, at 0.638, and fell to 0.633 in 2021. It improved to 0.644 in 2022. In this report. some of India's neighbouring countries have better HDI ranks – Malaysia (63); Thailand (66); China (75); Sri Lanka (78); Indonesia (112); Bhutan

(125), and Bangladesh (129). The HDR also presents interpolated consi data which can be used to compare HDI values across years and countries. India saw its HDI value increase by 48.4%, from 0.434 in 1990 to 0.644 in 2022. As for HDI rankings, during 2015-2022, India improved by four ranks, while neighbouring countries such as Bangladesh and Bhutan improved by 12 and 10 ranks, respectively China improved by 18 ranks. India's human development initiatives lagged behind during 2015-22. One of the reasons for the slow growth is the COVID-19 pandemic and its impact on dimensions of human development such as education and income

Gender gaps

The HDR also presents the Gender Development Index (GDI) for 193 countries. It measures disparities in human development by gender. The report contains HDI values estimated separately for women and men, the ratio of which is the GDI value. The closer the ratio is to one, the lesser the

gap there is between women and men.
Among the 42 'medium human development countries' to which India belongs, there are only seven with low equality in HDI achievements between women and men. These countries, with absolute deviation from gender parity of more than 10%, are India, Bangladesh, Nepal, Uganda,

Morocco, the Syrian Arab Republic, and Kiribati. India has one of the largest gender gaps in the Labour Force Participation Rate (LFPR) a 47.8 percent points difference between women (28.3%) and men (76.1%). Female labour force participation rate in India is very low when compared to many countries, more so when one compares it with India's neighbouring countries where in China it is 53.6 %, Bhutan 53.5 %, and Bangladesh 39.2%.
In the latest Periodic Labour Force Survey

In the latest retrodic Ladour Police Sur vey (PLFS) 2022-23, published by the Ministry of Statistics and Program Implementation, around 37% females of working age (15 years and above) were in the labour force in 2022-23; it was 23.3% in 2017-18. However, there is a huge gap in female labour force participation in rural and urban areas. While the female labour force participation rate in rural areas increased from 24.6% in 2017-18 to 41.5% in 2022-23, there is only a marginal increase in urban areas (from 20.4% to 25.4%). This is a matter of concern that requires further

research and in-depth study aimed at feasible

policy initiatives. Income inequality

In addition to the gender gap in income, inequality of incomes is also on the rise. India is one of the countries where income shares held by the richest 1% is very high (21.7%) compared to Bangladesh (11.6%), China (15.7%), Bhutan (18.1%), and Nepal (9.7%). Income inequality in India is also higher than the world average of 17.5% and the South Asia average of 19.6%. Most importantly, income inequality is also higher than other regional groups such as East Asia and the Pacific (16.5%) and Europe and Central Asia

India needs to address these gender development issues and increasing inequality in order to achieve the SDGs.
