Disability Inclusion and Barrier-Free Environment



Support Services and Reasonable Accommodation

IFHE funds and implements a wide spectrum of support services for persons with disabilities. This includes full-time or part-time personal assistance, reading and writing support, assistive devices/technology, and adjustments for evaluation and teaching methods as needed. Reasonable accommodation requests are processed quickly, with no cap on funding for deserving cases. Staff are trained annually in legal and practical aspects of inclusion and accommodation. Library and IT resources are provided in accessible formats; faculty members are assigned to mentoring roles for ongoing support.

Gender Equality and Empowerment Initiatives

1. Shaping financial well-being: the dynamic role of socialization and knowledge—a structural equation modeling approach

his study examines the influence of financial socialization processes on financial well-being among business students, specifically recognizing the mediating role of financial knowledge. Using data from 320 students, the authors find that peer and social media influence on student financial well-being operates mainly via improved financial knowledge, while parental influence is less direct. The findings argue for the implementation of robust financial literacy and digital skills programs in university curricula, with broader implications for policy and sustainable development.

2. Is socioeconomic segregation of the poor associated with higher premature mortality under the age of 60? A cross-sectional analysis of survey data in major Indian cities

This research analyzes whether isolation of poor households within Indian urban spaces is linked to increased rates of premature death (under age 60). Drawing upon survey data for over a million city dwellers, the authors reveal that greater segregation of the poor is indeed associated with higher premature mortality risk. As India continues to urbanize, these patterns require policy attention in urban planning and public health.

3. Does financial inclusion control corruption in upper-middle and lower-middle income countries?

This empirical investigation assesses whether rising financial inclusion contributes to the reduction of corruption in various economies. The study concludes that, provided financial inclusion surpasses certain thresholds, it has a meaningful effect in curbing corruption in both upper- and lower-middle-income countries. The results call for tailored country-level strategies on inclusion as a tool for combating inequality and improving governance.

4. Evidence for Life Satisfaction Among Dual-Career Couples: The Interplay of Job, Career, and Family Satisfaction in Relation to Workplace Support

This article examines life satisfaction among Indian dual-career couples, analyzing how workplace support (including supervisor and coworker assistance, work autonomy, and family-work balance) contributes to well-being. The study finds that the effect of workplace support is mediated by increases in job, career, and family satisfaction, pointing to the value of supportive organizational environments for improving the well-being of dual-career families.
